Note: Due to visa requirements, international students must attend courses on-campus, which includes taking online courses in the Fort Washington computer lab.

Temple University uses Zoom as the teaching platform, which is provided for free to all registered Temple students.

Required hardware

RAQA online courses are interactive, so you must have a webcam and microphone to participate. These are essential to provide an excellent online classroom experience for all students. Many laptops have built-in webcams and speakers. If you plan to use a device that does not, you are required to purchase them.

Proctorio is an online proctoring service that enables you to take exams at almost any location. <u>If a course uses</u> Proctorio, all students in the course must use that service.

Proctorio exams require a laptop or computer. Chrome notebooks, iPads, cell phones and other devices do not work. You must have **administrative access** to your laptop or computer, which means you can install software. Work computers may have built-in firewalls that prohibit software downloads. Please check this before registering.

Description: An overview of the regulation of artificial intelligence and machine learning-enabled (AI/ML) medical devices by various regulatory authorities with emphasis on the U.S. and E.U. Starting with the basics of an AI/ML-enabled medical device, the course dives into how devices are characterized/classified and the special considerations that must be accounted for in their design, development, and deployment. Topics include rapidly evolving legislative and global frameworks to regulate AI/ML devices, the need for harmonization, and the challenges regulators face with constant AI/ML advances. Examines several types of AI/ML-enabled devices that have been cleared/approved and the potential for new innovations. Reviews the data used to train AI/ML models for use in medical devices, a detailed overview of locked versus learning models, and the impact of bias in training, validating, testing, and deploying models, and the need for equity, diversity, and representativeness in AI/ML model development. Includes a discussion on the role of industry in developing safeguards for the use of AI/ML in medical devices, ethical considerations, and recent developments in global regulatory policies.
